1 Accounting policies

Sorensons Motors Limited ("the company") is a private company incorporated and domiciled in the UK. The company is registered in England and Wales under company registration number 665557. The registered office address is Othello House, Stratford-upon-Avon Business and Technology Park, Banbury Road, Stratford-upon-Avon, Warwickshire, CV37 7GY.

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the company's financial statements.

Basis of preparation

These financial statements were prepared in accordance with FRS 102 The Financial Reporting Standard applicable in the UK and Republic of Ireland as issued in March 2018 ("FRS 102"). The presentation currency of these financial statements is pounds sterling. The financial statements are prepared on the historical cost basis.

In the transition to FRS 102 from old UK GAAP, the company made no measurement or recognition adjustments. The company has applied the exemption for dormant companies set out in FRS 102 Section 35 such that the accounting policies for reported assets, liabilities and equity at the date of transition have been retained until there is any change in those balances or the company undertakes any new transactions.

The company's parent undertaking, Listers Group Limited, includes the company in its consolidated financial statements.
