## **Statement of Directors' responsibilities in respect of the Directors' report and the financial statements**

- assess the company's ability to continue as a going concern, disclosing, as applicable, matters related to going concern;
- use the going concern basis of accounting unless they either intend to liquidate the company or to cease operations, or have no realistic alternative but to do so.

The Directors are responsible for keeping adequate accounting records that are sufficient to show and explain the company's transactions and disclose with reasonable accuracy at any time the financial position of the company and enable them to ensure that the financial statements comply with the Companies Act 2006. They are responsible for such internal control as they determine is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error, and have general responsibility for taking such steps as are reasonably open to them to safeguard the assets of the company and to prevent and detect fraud and other irregularities.



### 1 Accounting policies

Sorensons Motors Limited ("the company") is a private company incorporated and domiciled in the UK. The company is registered in England and Wales under company registration number 665557. The registered office address is Othello House, Stratford-upon-Avon Business and Technology Park, Banbury Road, Stratford-upon-Avon, Warwickshire, CV37 7GY.

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the company's financial statements.

#### *Basis of preparation*

These financial statements are prepared in accordance with FRS 102 The Financial Reporting Standard applicable in the UK and Republic of Ireland as issued in January 2022 ("FRS 102"). The presentation currency of these financial statements is pounds sterling. The financial statements are prepared on the historical cost basis.

In the transition to FRS 102 from old UK GAAP, the company made no measurement or recognition adjustments. The company has applied the exemption for dormant companies set out in FRS 102 Section 35 such that the accounting policies for reported assets, liabilities and equity at the date of transition have been retained until there is any change in those balances or the company undertakes any new transactions.

The company's parent undertaking, Listers Group Limited, includes the company in its consolidated financial statements. The consolidated financial statements of Listers Group Limited are available to the public and may be obtained from Othello House, Stratford-upon-Avon Business and Technology Park, Banbury Road, Stratford-upon-Avon, Warwickshire, CV37 7GY.
