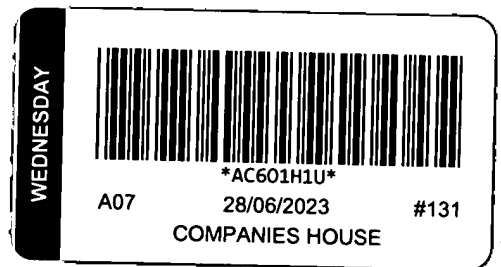

**1. General information**

The company was dormant during the year and did not trade.

Thames Television Animation Limited is a private company, limited by shares, incorporated and domiciled in England and Wales, registration number 00975809. The address of its registered office is 1 Stephen Street, London, W1T 1AL.

**2. Accounting policies****2.1 Basis of preparation of financial statements**

The financial statements have been prepared under the historical cost convention unless otherwise specified within these accounting policies and in accordance with Financial Reporting Standard 102, the Financial Reporting Standard applicable in the UK and the Republic of Ireland and the Companies Act 2006.

The preparation of financial statements in compliance with FRS 102 requires the use of certain critical accounting estimates. It also requires management to exercise judgment in applying the Company's accounting policies.

**2.2 Financial reporting standard 102 - reduced disclosure exemptions**

- the requirements of Section 33 Related Party Disclosures paragraph 33.7.

**2.3 Debtors**
