### 1. GENERAL INFORMATION

#### Agency Agreement

Under the terms of an agreement dated 10 December 1987, the Company acts as a manager and agent for the parent undertaking, Sanderson Design Group Brands Limited, which is responsible for the discharge of all liabilities incurred by the Company.
