

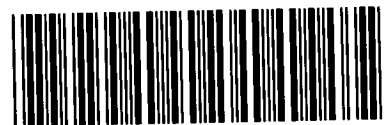

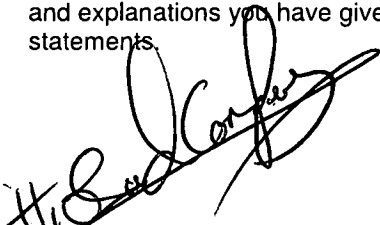

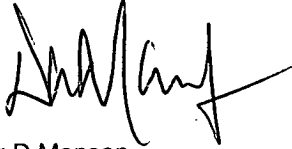

1. General information

The company is a private company limited by shares, registered in England and Wales. The address of the registered office is 83 High Street, Hemel Hempstead, Hertfordshire, HP1 3AH.
