**BEFORE DEPUTY ICC JUDGE FRITH sitting in Chambers on 3 NOVEMBER 2023**

**UPON THE APPLICATION OF** Susan Agnes Maund dated 31 October 2023 for a Block Transfer Order

**AND UPON READING** the papers on the Court file recorded as being read, including the witness statement of Susan Agnes Maund dated 31 October 2023

**AND UPON** the Court considering it appropriate to make the order without a hearing pursuant to Rule 12.38(1) and (2)(b) of the Insolvency (England and Wales) Rules 2016

**IT IS ORDERED THAT:**

1. Susan Agnes Maund (the **outgoing office-holder**) be removed from office in respect of each of the ongoing cases listed in Parts 1, 2, 3, and 4 of Schedule 1 annexed to this Order (**block transfer cases**) from the date of this order pursuant to Rule 12.37(2) of the Insolvency (England and Wales) Rules 2016 ("IR 2016") without being required (i) to use one of a decision procedures or deemed consent procedures set out in the Insolvency Act 1986 (as amended) ("the Act") or IR 2016 for Block Transfer Cases; or (ii) to apply to the Secretary of State for release or discharge pursuant to the Act; or (iii) to file receipts and payments accounts.
2. Thomas Richard Milbourne D'Arcy and Christopher James Latos (**replacement office-holders**) replace the outgoing office-holder and be appointed as joint replacement office-holders in respect of each of the block transfer cases listed in Parts 1, 2, 3 and 4 of Schedule 1 from the date of this order pursuant to Rule 12.37(3) of IR 2016 without being required (i) to use one of a decision procedures or deemed consent procedures set out in the Act or IR 2016 for Block Transfer Cases; or (ii) to apply to the Secretary of State for release or discharge pursuant to the Act; or (iii) to file receipts and payments accounts.
3. The creditors in each of the block transfer cases listed in Parts 1, 2, 3 and 4 of Schedule 1 be notified of this order by one composite advertisement published in the London Gazette within 21 days of receipt of the Court's sealed Order in this matter. Such advertisement containing the information set out in Schedule 1 shall be sufficient to comply with the requirements of Rule 1.6 and Chapter 4 of Part 1 (Rules 1.10 to 1.14) of IR 2016.
4. Any creditor, or in the case of any members' voluntary liquidation, any member, in respect of any of the companies or persons listed in Parts 1, 2, 3 and 4 of Schedule 1 who has an objection to this order shall have 21 days from the date of the publication of the advertisement of this Order, pursuant to paragraph 3 above, in which to apply to court to set aside or vary the terms of this order. Such application shall not affect the transfer of the block transfer cases listed in Schedule 1 unless ordered by the Court.
5. The replacement office-holders shall, as soon as reasonably practicable, give notice of this Order to the Secretary of State and, in respect of the liquidations listed in Schedule 1, to the Registrar of Companies.
6. The outgoing office-holder shall file a copy of this order with each of the courts listed in Schedule 1.
7. The outgoing office-holder shall receive her release as Liquidator or Supervisor (as the case may be) 21 days after the date of publication of the advertisement referred to in

paragraph 3 of this Order, save that such release may be subject to further order in the event of an application by any creditor or member under paragraph 4 of this Order for the specific case subject to that application.

8. The outgoing office-holder shall receive her release as provided for under paragraph 7 of this order without being required (i) to apply to the Secretary of State for her release or discharge as appropriate pursuant to s.173(2)(b), s.174(4)(b) of the Act as the case may be or (ii) to file a receipts and payments account.
9. The replacement office-holders shall in the next progress report after the date of this order, notify creditors or, in the case of any members' voluntary liquidation, members of the making of this Order. In the case of those block transfer cases where the final account or the final report has already been delivered and the statutory time limit for a creditor or a member making any further representations or applications has expired or will expire within 8 weeks; publication of the advertisement in accordance with paragraph 3 of this order alone shall be deemed sufficient delivery of notice of this order under rule 12.38(6)(b)(i) of the Rules.
10. In respect of each of the block transfer cases where the Replacement Office-Holders are appointed as joint office-holder, any act required or authorised to be done by the joint office-holders may be done by all or anyone or more of them.
11. No order as to costs.
