

#### 3. BACKGROUND

- Following incorporation the Company became a leading provider and installer of specialist window films in the North East of England offering a long life and cost efficient method of adapting glass to individual requirements
- As contracts became larger, the Company began to suffer larger bad debts. During 2008 the Company suffered a very large debt when a main contractor on a large office development for the Crown went into liquidation. This resulted in a significant loss of immediate cashflow and the Company began to scale back its contracts in an attempt to save a smaller business. The directors also attempted to negotiate a settlement/repayment agreement with its major creditor, H M Revenue & Customs. Unfortunately this agreement did not occur.
- On 7 September 2009 HM Revenue & Customs presented a winding up petition against the Company in respect of unpaid PAYE, National Insurance contributions, interest and penalties totaling £113,516. The Company was served with a petition on or about the 9 September 2009. The directors then agreed that despite their very best endeavors that the Company could not be saved from some form of insolvency proceedings and took independent advice.
- On 21 October 2009, at a hearing in the High Court of Justice, Newcastle upon Tyne District Registry the court appointed Peter W Gray and J Harvey Madden as Joint Administrators of the Company with authority to act jointly or severally
- The Company had a secured creditor, RMD Factors Limited, who have a debenture registered at Companies House which confers the power to appoint an administrator. No monies were owed to RMD Factors and therefore they were not entitled to appoint an Administrator

#### 4. PURPOSE OF ADMINISTRATION

  - rescuing the Company as a going concern, or
