NOTES TO ESTIMATED STATEMENT OF AFFAIRS AS AT 10 OCTOBER 2022

- 1. The Company's remaining stock schedule is not up-to-date following the recent closing down sale and will be subject to the analysis of the liquidators and their agents, however, it is anticipated that the stock will retain significant value to a buyer within the trade. The Company's furniture and equipment is not expected to be of any value to the estate as the costs of removal and sale would outweigh the value.
- 2. This represents the preferential element of sums owed to the Company's former employees in respect of arrears of wages and holiday pay. Following payment by the Redundancy Payments Service, it is anticipated that the majority of this sum will eventually be subrogated to the Secretary of State.
- 3. This total is made up of sums owed to HM Revenue & Customs in respect of VAT, PAYE and Employee's National Insurance Contributions.
- 4. Lloyds Bank PLC ("Lloyds") holds a fixed and floating charge debenture over the Company created on 4 May 2001 and registered on 10 May 2001, however, there is currently no liability to Lloyds under the charge. The Coronavirus Bounce Back Loan received by the Company from Lloyds during the pandemic is not subject to the security and constitutes an unsecured debt.

Section 176A(1)(a) of the Insolvency Act 1986 requires the liquidators to set aside a prescribed part of the Company's net property for the satisfaction of unsecured debts where a company has created a floating charge after 15 September 2003. The prescribed part is 50% of the first £10,000 and 20% of the remaining net property (up to a maximum of £800,000). In this instance, the charge was created prior to 15 September 2003 and consequently the provisions of Section 176A(1)(a) will not apply.

- 5. This consists of the sum owed to HM Revenue & Customs in respect of Employer's National Insurance Contributions.
- 6. This represents the non-preferential element of sums potentially owed to the Company's former employees in respect of arrears of wages, notice pay and redundancy pay. Following payment by the Redundancy Payments Service, it is anticipated that the majority of this sum will eventually be subrogated to the Secretary of State.

Begbies Traynor were engaged to assist the Directors in the preparation of the Statement of Affairs under section 99 and with the Qualifying Decision Procedure. A initial fee of £6,000 plus VAT was agreed for the work and has been advanced to Begbies Traynor's stakeholder account.

Costs of liquidation are not included in the above analysis.
