PRINCIPAL ACTIVITY

The principal activity of the company in the year under review was that of the management of Flat A-D, 8 Old Oak Road, London, W3 7HL. As part of the management of that property, service charges are collected from lessees to meet the costs of managing and maintaining the property. Service charges are held in trust for the benefit of the lessees. Accordingly the service charge income and expenditure is excluded from the company's accounts and separate service charge accounts are prepared.

This company is limited by guarantee, with no share capital.
