**UPON READING** the Application of the Applicant dated 13 April 2022 pursuant to Chapter 6 (Subdivision B) of Part 12 of the Insolvency (England and Wales) Rules 2016 (SI 2016 / 1024).

**AND UPON READING** the Witness Statement of the Applicant dated 13 April 2022 which exhibited the consent of the Respondents to the terms of this Order.

#### IT IS ORDERED THAT:

#### 1. TRANSFER BETWEEN COURTS

- 1.1. Each of the County Court and hearing centre cases, District Registry cases and Office of the Adjudicator cases listed in Schedule B and D of this Order ("Relevant Court Cases") be transferred to the High Court of Justice, Business and Property Courts of England and Wales, Insolvency and Companies Court List (ChD) pursuant to Rule 12.38 (2)(a) Insolvency Rules 2016 solely for the purpose of making a Block Transfer Order of the Applicant's appointments.
- 1.2. Immediately upon the making of this Order the Relevant Court Cases be transferred back to the relevant County Court or hearing centre, District Registry or Office of the Adjudicator without further order.

#### 2. APPLICANT'S REMOVAL AS OFFICEHOLDER

- 3.5.2. companies in Compulsory Liquidation is made pursuant to Section 172 Insolvency Act 1986 and rule 12.36(2)(a) Insolvency (England and Wales) Rules 2016.
- 3.5.3. companies in Members Voluntary Liquidation is made pursuant to Section 108 Insolvency Act 1986 and rule 12.36(2)(a) Insolvency (England and Wales) Rules 2016.
- 3.5.4. Bankruptcy Estates is made pursuant to Section 298(1) Insolvency Act 1986 and rule 12.36(2)(c) Insolvency (England and Wales) Rules 2016.

- 3.6.
