### **1 Accounting policies**

#### **Company information**

Poplar Grange Barnt Green Management Ltd is a private company limited by guarantee incorporated in England and Wales. The registered office is 5 Laurel Gardens, Barnt Green, Birmingham, West Midlands, B45 8RP.

#### **Accounting convention**

These financial statements have been prepared in accordance with FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" ("FRS 102") and the requirements of the Companies Act 2006 as applicable to companies subject to the small companies regime. The disclosure requirements of section 1A of FRS 102 have been applied other than where additional disclosure is required to show a true and fair view.

The financial statements have been prepared under the historical cost convention, modified to include the revaluation of freehold properties and to include investment properties and certain financial instruments at fair value. The principal accounting policies adopted are set out below.

### **2 Employees**

The average monthly number of persons (including directors) employed by the company during the year was 5 (2018 - 5).

### **3 Members' liability**

The company is limited by guarantee, not having a share capital and consequently the liability of members is limited, subject to an undertaking by each member to contribute to the net assets or liabilities of the company on winding up such amounts as may be required not exceeding £1.

### **4 Ultimate controlling party**

There is no ultimate controlling party.

### **5 Service charge accounts**

Separate service charge accounts are prepared detailing the income and expenditure for Poplar Grange.
