1. ACCOUNTING POLICIES

Basis of preparing the financial statements

During the period to 31 March 2015, the Company incurred a net loss of £3,622 (2014: net loss of £2,460). At 31 March 2015, its net current liabilities amounted to £91,670 (2014: £88,552) and the shareholders' net liabilities were £90,247 (2014: £86,625). The Company is dependant upon the continued financial support of its bankers, directors and shareholders.

Accounting convention

The financial statements have been prepared under the historical cost convention and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008).

Tangible fixed assets

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

Motor vehicles - 25% on reducing balance Computer equipment - 3 years straight line

Stocks

Work in progress is valued at the lower of cost and net realisable value.

Cost includes all direct expenditure and an appropriate proportion of fixed and variable overheads.

Deferred tax

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date.
