ORDER

UPON the Application by Application Notice dated 13 July 2020 of Bijal Shah of Edge Recovery ("The Application")

AND UPON considering the Application on paper

AND UPON READING the documents on the Court file recoded as having been read

IT IS ORDERED THAT:

1. The Applicant has leave to make a composite application in respect of the insolvency proceedings identified in the Schedule attached to the Application ("the insolvencies").
2. Any Insolvencies listed in the Schedule which are pending in a County Court be transferred to the High Court Solely for the purpose of this application.
3. The Respondent be removed from office as Liquidator, in respect of each of the Insolvencies in which he holds such office.

4. The Applicant being a Licensed Insolvency Practitioner of Edge Recovery of be appointed in place of the Respondent as the sole Liquidator, in respect of each of the Insolvencies, in each case with immediate effect.
5. The Respondent is not required to produce any progress reports on ceasing to act as officeholder pursuant to this Order.
6. The Applicant shall, as soon as reasonably practicable of making of this Order, procure that a block advertisement in relation to the Insolvencies is placed in the London Gazette, informing creditors of the following matters:
 - a) The making of this Order, including in particular the substitution of the Applicant for the Respondent and the details of the substitution.
 - b) The liberty to apply provision contained in paragraph 9 below.
7. Notice of the matters set out in paragraph 6 above shall also be given to the Registrar of Companies as soon as reasonably practicable after making of this Order.
8. As to the costs of this Application:
 - a) The remuneration of and the costs and expenses incurred by the Applicant and/or the Respondent in connection with this Application and the implementation of this Order which are referable to an individual matter listed in the Schedule hereto be fixed and paid in the ordinary way as remuneration of the Liquidator, or as costs and expenses of such liquidation;
 - b) The remuneration of and the costs and expenses incurred by the Applicant and/or Respondent in connection with this Application generally be divided equally between all the Insolvencies; and that the said costs be paid in the ordinary way as remuneration of the Liquidator or as costs and expenses of each such liquidation;

PROVIDED THAT in no case shall the total of such remuneration, costs and expenses (including VAT) payable under 8 (a) and 8 (b) above exceed 10% of the value of the realised assets in that particular matter.

(c) Any costs and expenses incurred by the Applicant and/or the Respondent in connection with this Application which are not recoverable in accordance with paragraphs 8 (a) and 8 (b) above, will be paid by the Applicant.

9. There be liberty to apply to any Creditor of the Companies referred to in the Schedule within 28 days of placing the advertisement referred to in paragraph 6 above to vary or discharge this Order.

10. Such further order as the Court sees fit.
