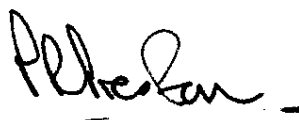

The quorum being present, the meeting was declared open.

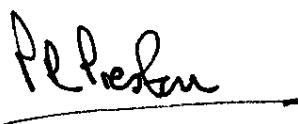
