#### 1. ACCOUNTING POLICIES

#### 1 1 Basis of preparation of financial statements

#### 1 2. Cash flow

#### 1.3. Turnover

Turnover comprises the invoiced value of goods and services supplied by the company, exclusive of Value Added Tax
