AND IT IS ORDERED THAT the costs of the petitioner of the said petition be paid out of the assets of the company

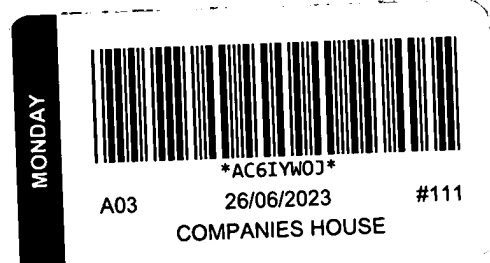
