# **Principal Activity**

The principal activity of the company throughout the period has been the maintenance of Angus Wood, a community woodland on St Leonards Avenue in Blandford Forum leased from the Woodland Trust. The wood remains extremely popular with local people. Maintenance has included a substantial number of work days with a small group of BET members, Friends of Angus Wood volunteers from the local community, maintaining social distancing in 2020. Husbandry has focused on clearing paths and cutting back dogwood and other fast growing species to encourage the many new trees planted over the last 6 years.

Fund raising activity involving the local community has been limited by weather and then the 2020 pandemic restrictions but due to the Treasurer's foresight we were able to meet the cost of public liability insurance and maintenance from our reserves.
