4.2. Late payment compensation

A claim was made in respect of late payments from Warwickshire County Council and a settlement of £7,500 was agreed.

Delv Limited identified and negotiated the settlement and has been paid £1,125 in this respect.

5. Investigation

I have investigated the reasons for the failure of the company and have fulfilled my duty in reporting on the conduct of the Director to the Insolvency Service.

6. Creditors

Unfortunately, as the Company was not VAT registered, there are insufficient monies to enable a dividend to any class of creditor. Therefore, creditors' claims have not been fully agreed.
