PRINCIPAL ACTIVITY

The principal activity of the Company in the year under review was the provision of Funding & Business Support for Birmingham Grass Roots Cricket & Cricketers.

REVIEW OF BUSINESS

The business was incorporated on 11 July 2011 and has operated within its Aims & Objectives during the period under review.

The BILL LLOYD Memorial Trust Limited continues to be an integral supporter of local Birmingham Cricket particularly Youth and Disability Cricket. The Company is working in close association with the ECB (England & Wales Cricket Board), the WCB (Warwickshire Cricket Board) and similar such organisations including charitable institutions such as the Army Benevolent Fund and the Royal British Legion.

The Company acquired Charity Status late January 2014 and continues the process of reviewing and upgrading its Business Plan including the development of a Management Board to assist in the positive development and sustainability of the Trust going forward.

No salaries have been paid to the Directors during the period under review.




