Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

Plant and machinery etc

- 25% on reducing balance

Stocks

Stocks are valued at the lower of cost and net realisable value, after making due allowance for obsolete and slow moving items.

Deferred tax

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date.

The company is under common control with CRC Developments Ltd, a company incorporated in England & Wales.

The Bridgnorth Cobbler Ltd acquired a cobblers business from CRC Developments Ltd which had previously purchased the business itself in the year to 31st March 2011. The goodwill acquired and fixed assets were transferred to The Bridgnorth Cobbler Ltd at market value upon incorporation.

No actual trading took place between the companies but The Bridgnorth Cobbler Ltd is repaying CRC Developments Ltd for a bank loan that the company took out to acquire the goodwill and fixed assets of the business.

At 31st March 2014 The Bridgnorth Cobbler Ltd owed CRC Developments Ltd in total £22066 and this is shown within creditors on the balance sheet.
