

- 4. - 5. The Respondent be removed from office as Supervisor of the Individual Voluntary Arrangements of the individuals listed in Schedule 5 hereto pursuant to section 263(5) of the Insolvency Act 1986, with effect from 30 November 2023 and the Applicant be appointed as Supervisor in substitution in respect of the said Individual Voluntary Arrangements, with effect from the same date, pursuant to section 263(5) of the Insolvency Act 1986.
- 6.
