### **PRINCIPAL ACTIVITIES**


The company has been dormant as defined in section 1169 of the Companies Act 2006 throughout the period. It is anticipated that the company will remain dormant for the foreseeable future.

#### **1. GENERAL INFORMATION**

Notion Nominees UK Limited (the "company") was dormant throughout the period.

The financial statements are presented in sterling which is the functional currency of the company.

The company is a private limited company incorporated in the United Kingdom and registered in England and Wales. The address of its registered office is 91 Wimpole Street, London, W1G 0EF.

The significant accounting policies applied in the preparation of these financial statements are set out below. These policies have been consistently applied in the current and preceding years.

#### **2. ACCOUNTING POLICIES**

##### **Basis of preparation**
