

(B) inform the Registrar of Companies of the title and Court reference number of the said Petition immediately after issue

(C) inform the Registrar of Companies of the outcome of the hearing of the said Petition

(D) within 14 days of the making of any compulsory winding up Order in respect of the Company deliver an Office Copy of that Order to the Registrar of Companies

(E) if no Order is made compulsorily winding up the Company in the meantime, at 6 monthly intervals from the date of the Order serve on the Registrar of Companies a full and sufficient Witness Statement setting out what steps have been taken to progress the Company's winding up

AND UPON the Claimant and the Solicitor for the Registrar of Companies (the Defendant) both consenting to this Order

IT IS ORDERED THAT

(1) the name of the above named Andavis Limited be restored to the Register of Companies

(2) if at the date of registration of this Order with the Registrar of Companies the name of the Company is not available the Registrar of Companies shall pursuant to Section 1033(2)(a)(ii) and (b) of the Companies Act 2006 change the name of the Company to 08320218 Limited



- (3) an Office Copy of the Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the Company is thereupon to be deemed to have continued in existence as if its name had not been struck off
- (4) the Registrar of Companies do advertise notice of this Order in his official name in the "London Gazette"
- (5) should the Claimant fail to comply with undertaking (E) above the Registrar of Companies reserves the right to strike off the Company without further reference to the Claimant
- (6) the hearing fixed for the 11 March 2016 be vacated


