In accordance with the provisions of Chapter 2 of Part 13 of the Companies Act 2006 (2006 Act), the following resolutions are proposed as three ordinary resolutions and two special resolutions of the Company:

ORDINARY RESOLUTIONS

- 1. **THAT**, in accordance with section 618 of the 2006 Act, the two ordinary shares of £1.00 each in the issued share capital of the Company be sub-divided into 200 ordinary shares of £0.01 each, such shares having the same rights and being subject to the same restrictions (save as to nominal value) as the existing ordinary shares of £1.00 each in the capital of the Company as set out in the Company's articles of association for the time being.
- 2. **THAT**, certain of the ordinary shares of £0.01 each in the capital of the Company be redesignated as follows:
 - a. the 100 ordinary shares of $\pounds 0.01$ each in the capital of the Company held by Christopher Allan Ashton be and are hereby redesignated as 80 A ordinary shares and 20 B ordinary shares, in each case of $\pounds 0.01$ each in the capital of the Company; and
 - b. the 100 ordinary shares of £0.01 each in the capital of the Company held by Rebecca Caroline Ashton be and are hereby redesignated as 80 A ordinary shares and 20 B ordinary shares, in each case of £0.01 each in the capital of the Company,
 - in each case having the rights and being subject to the restrictions set out in the articles of association adopted pursuant to resolution 5.
- 3. THAT, in accordance with section 551 of the 2006 Act, the directors of the Company (Directors) be generally and unconditionally authorised to allot shares in the Company or grant rights to subscribe for or to convert any security into shares in the Company (Rights) up to an aggregate nominal amount of £0.40, provided that this authority shall, unless renewed, varied or revoked by the Company, expire on the date being five years following the date of the passing of this resolution, save that the Company may, before such expiry, make an offer or agreement which would or might require shares to be allotted or Rights to be granted and the Directors may allot shares or grant Rights in pursuance of such offer or agreement notwithstanding that the authority conferred by this resolution has expired.

This authority is in substitution for all previous authorities conferred on the Directors in accordance with section 551 of the 2006 Act but without prejudice to any allotment of shares or grant of Rights already made or offered or agreed to be made pursuant to such authorities.

SPECIAL RESOLUTIONS

- 4. **THAT**, in accordance with section 570 of the 2006 Act, the Directors be generally empowered to allot equity securities (as defined in section 560 of the 2006 Act) pursuant to the authority conferred by resolution 3 above, as if section 561(1) of the 2006 Act (or any other rights of pre-emption on allotment, whether contained in the Company's articles of association or otherwise) did not apply to any such allotment, provided that this power shall:
 - 4.1 be limited to the allotment of equity securities up to an aggregate nominal amount of £0.40; and
 - 4.2 expire on the date being five years following the date of the passing of this resolution (unless renewed, varied or revoked by the Company prior to or on that date), save that the Company may, before such expiry make an offer or agreement which would or might require equity securities to be allotted after such expiry and the Directors may allot equity securities in pursuance of any such offer or agreement notwithstanding that the power conferred by this resolution has expired.
- 5. **THAT**, the draft regulations attached to this resolution be adopted as the articles of association of the Company in substitution for, and to the exclusion of, the existing articles of association.
