

UPON the Application of Molly Monks for a block transfer order dated
June 2021

AND UPON READING the evidence on the court file.

AND WHERE the Respondents agrees to the Application and the First Respondent shall continue as a supervisor.

AND UPON the court dealing with this application without a hearing pursuant to rule 12.38(1) of the Insolvency (England and Wales) Rules 2016 ("Rules").

IT IS ORDERED THAT:

- Each of the County Court cases listed in Schedule (attached to this order) be transferred to the High Court of Justice, Business and Property Court at Manchester for the purpose only of making this order.
- 2. Immediately upon this order taking effect, the County Court cases listed in the Schedule be transferred back to the County Court.

- Molly Monks (outgoing office-holder) be removed from office in respect of each of the cases listed in the Schedule attached to this order (block removal and transfer cases) from the date of this order.
- Darren Brookes (replacement office-holder) be appointed as replacement office-holder in respect of STL Heating and Energy Limited (In Liquidation) and Mazeridge Limited (In Liquidation) as listed in the Schedule from the date of this order.
- 5. The creditors in each of the block transfer cases listed in the Schedule shall be notified of this order by one composite advertisement published in the London Gazette within 21 days from the date of this order. An advertisement containing the information set out in the Schedule shall be sufficient to comply with the requirements of rule 1.6 and Chapter 4 Part 1 (rules 1.10 to 1.14) of the Rules.
- 6. Any creditor, or, in the case of any members' voluntary liquidation, any member, in respect of any of the listed in the Schedule who has an objection to this order shall have 21 days from the date of the publication of the advertisement as referred to at paragraph 5 to apply to court to set aside or vary the terms of this order. Such application shall not affect the transfer of the block transfer cases listed in the Schedule until further or other order by the court.
- 7. The replacement office-holder shall as soon as reasonably practicable give notice of the terms of this order to the Secretary of State and to the Registrar of Companies.
- The outgoing office-holder shall file a copy of this order with each of the courts listed in the Schedule.
- 9. Molly Monks shall receive her release as administrator, liquidator or supervisor 21 days after the date of the publication of the advertisement referred to at paragraph 5 save that such release may be subject to further order in the event of an application by any creditor or member under paragraph 6, in so far as her release relates to the specific case which is subject to that application.
- 10. Molly Monks shall receive her release as provided for under paragraph 9 without being required to (i) apply to the Secretary of State for her release or discharge as appropriate pursuant to s.174(4)(b) of the Insolvency Act 1986 as the case may be or (ii) being required to file a receipts and payments account.
- 11. In respect of any of the block transfer cases where the replacement office-holder is appointed as joint office-holder, any act required or authorised to be done by the joint office-holders may be done by all or any one or more of them
- 12. No order as to costs.
- 13. Such further or other order or direction as the court sees fit.
- 14. Liberty to apply.
