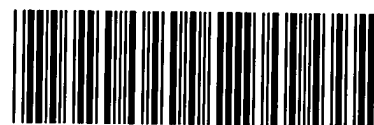

Principal Activity


