#### DEED OF EQUITABLE CHARGE

**THIS DEED OF EQUITABLE CHARGE** is made potentially in counterparts on 14th July 2023 in relation to a Deed of Addition and Contribution Agreement made on the 21<sup>st</sup> day of September Two Thousand and Twenty-One between the same parties as in this Deed ("the Contribution Agreement") and the instruments to which the Contribution Agreement was stated to be supplemental.

#### **BETWEEN:**

(1) ALPHA REPUBLIC LIMITED a corporation established under the laws of England and Wales, company number 09263239, of which the registered office is at 85 Great Portland Street, London, England, W1W 7LT (hereinafter called "the Settlor")

and

(2) **PS 500 LTD** a corporation established under the laws of England, company number 13629532, of which the registered office is at 20–22 Wenlock Road London England N1 7GU (hereinafter called "the EMS Trustee")

## WHEREAS:-

- (A) Words and expressions contained in the Contribution Agreement and defined therein (whether expressly or by reference to other instruments) shall, unless the context requires, have the same meaning herein
- (B) The EMS Trustee remains the sole trustee of the Settlement and enters into this Deed in its capacity as trustee of the Settlement. In consequence, references herein to "the EMS Trustee" shall, provided the context permits:

(a) be construed as references to the EMS Trustee only in its capacity as trustee of the Settlement and

(b) shall include the trustee or trustees from time to time of the Settlement.

(C) By the Contribution Agreement, the Settlor entered into certain covenants with the EMS Trustee so that the EMS Trustee should hold the benefit of such covenants as trustee of the Settlement as an accretion to the First Sub-Fund, the Second Sub-Fund and the Third Sub-Fund in the same proportions which the Profits of the Settlor for the First Accounting Period, the Second Accounting Period and the Third Accounting Period bore to each other.

#### DEED OF EQUITABLE CHARGE

(D) By clause 3 of the Contribution Agreement, the Settlor covenanted with the EMS Trustee to make certain periodic payments ("the Periodic Payments") to the EMS Trustee, subject to the proviso that if the Settlor should have entered into one or more Deeds of Equitable Charge in the form, as near may be, set out in the First Schedule thereto (i.e. in substance in the form of this Deed) whereby the creditor's rights under one or more debts owed to the Settlor by certain persons are charged in Equity with the due performance of the obligation of the Settlor under clause 2 of the Contribution Agreement and shall have given a certified copy thereof to the EMS Trustee, if it is not a party thereto, then for so long as and to the extent that

(i) the obligation to repay the Settlor has not been performed or discharged

(ii) the creditor's rights to the debt remain charged in accordance with the Deed of Equitable Charge and

(iii) neither the Settlor nor any successor in title of the Settlor requires any interest or periodic payment to be made by the debtor in respect of the debt

the amount or value from time to time of any such debt should be deducted in computing the Unperformed Amount (by reference to which the quantum of the periodic payments was to be calculated).

(F) The Settlor is desirous of entering into this Deed in order to charge in equity its creditor's rights under certain such debts with the due performance of the obligations of the Settlor arising under clause 3.1 of the Contribution Agreement, with a view to altering its liability to make the Periodic Payments.

## NOW THIS INSTRUMENT WITNESSETH as follows:-

- 1. The Settlor hereby **CHARGES IN EQUITY** its rights as creditor more particularly described in the Schedule hereto ("the Charged Property") in favour of the EMS Trustee in order to secure the due performance of the obligations of the Settlor arising under clause 2 of the Contribution Agreement.
- 2. For the avoidance of doubt, the Settlor is not hereby contracting or covenanting with the EMS Trustee to grant in favour of the EMS Trustee any legal charge of the Charged

Property or to make any assignment or other transfer (whether by way of security or otherwise) of the Charged Property to or to the order of the EMS Trustee. The EMS Trustee shall have no such right and the rights of the EMS Trustee under this Equitable Charge shall be limited to those of an equitable chargee of a chose in action.

3. This Agreement shall be governed by and construed in accordance with the laws of England.

**IN WITNESS whereof** the parties hereto have duly executed and unconditionally delivered this Deed as a deed the day and year above written.


