1. DEFINITIONS AND INTERPRETATION

2. CREATION OF SECURITY

- The Borrower shall pay or discharge the Secured Liabilities in the manner provided for in the Finance Documents.
 - All the security created under this Deed is:
 - (i) created in favour of the Lender;

 - (ii) security for the payment of all the Secured Liabilities; and (iii) made with full title guarantee in accordance with the Law of Property (Miscellaneous Provisions) Act 1994.

 - (iii) in payment to the Lender in accordance with the Facility Agreements; and
 - b. in payment of the surplus (if any) to the Borrower or other person entitled to it.

10. DELEGATION

- 10.1. The Lender or any Receiver may, at any time, delegate by power of attorney or otherwise to any person for any period, all or any right; power, authority or discretion exercisable by it under this Deed.
- Neither the Lender nor any Receiver shall be bound to supervise, or will be in any way responsible for any damages, costs or losses incurred by reason of any misconduct, omission or default on the part of any delegate or sub-delegate.

11. FURTHER ASSURANCES

11.1.

- a. The Borrower shall promptly, at its own expense, take whatever action the Lender or a Receiver may require for:
 - (i) creating, perfecting or protecting any security over any Security Asset; or
 - (ii) facilitating the realisation of any Security Asset, or the exercise of any right, power or discretion exercisable, by the Lender or any Receiver or any of their respective delegates or sub-delegates in respect of any Security Asset.
- b. The action that may be required under paragraph (a) above includes (without limitation):

PRESERVATION OF SECURITY 13.

If any discharge, release or arrangement (whether in respect of the obligations of the Borrower or any security for those obligations or otherwise) is made by the Lender in whole or in part on the basis of any payment, security or other disposition which is avoided or must be restored in insolvency, liquidation, administration or otherwise, without limitation, the liability of the Borrower under this Deed will continue or be reinstated as if the discharge, release or arrangement had not occurred.

MISCELLANEOUS

- This Security is a continuing security and shall extend to the ultimate balance of the Secured Liabilities for the Security Period regardless of any intermediate payment or discharge in whole or in part,
- The Lender shall perform its obligations under each Facility Agreement (including any obligation to make available further

 - b. an amendment includes a supplement, novation, extension (whether of maturity or otherwise), restatement, re-enactment or replacement (in each case, however fundamental and whether or not more onerous or involving any change in or addition to the parties to any agreement or document) and amended shall be construed accordingly;
 - assets includes present and future properties, revenues and rights of every description;
 - d. disposal includes a sale, transfer, assignment, grant, lease, licence, declaration of trust or other disposal, whether voluntary or involuntary and dispose shall be construed accordingly;
 - e. a Finance Document or any other agreement or instrument is a reference to that Finance Document or other agreement or instrument as amended;
 - f. a person includes any individual, firm, company, corporation, government, state or agency of a state or any association, trust, joint venture, consortium, partnership or other entity (whether or not having separate legal personality);
 - g. a regulation includes any regulation, rule, official directive, request or guideline (whether or not having the force of law) of any governmental, intergovernmental or supranational body, agency, department or of any regulatory, self-regulatory or other authority or organisation;
 - h. any rights in respect of an asset includes:
 - all amounts and proceeds paid or payable;
 - (ii) all rights to make any demand or claim; and

- (iii) all powers, remedies, causes of action, security, guarantees and indemnities, in each case, in respect of or derived from that
- the term this Security means any Security created by this Deed; an agreement, instrument or other document to which it is a party includes any agreement, instrument or other document issued
- in the relevant person's favour or of which it otherwise has the benefit (in whole or in part); and j.
- a provision of law is a reference to that provision as amended or re-enacted.
- Clause and Schedule headings are for ease of reference only and do not affect the interpretation of this Deed. 2.2.
- Unless a contrary Indication appears, a term used in any other Pinance Document or in any notice given under or in connection with any Finance Document has the same meaning in that Finance Document or notice as in this Deed. 2.3.
- An Event of Default is continuing if it has not been remedied or waived. 2.4.
- Any covenant of the Borrower under this Deed (other than a payment obligation which has been discharged) remains in force during the Security Period.
- The terms of the other Finance Documents and of any other agreement or instrument between any Parties in relation to any Finance Document are incorporated in this Deed to the extent required to ensure that any purported disposition, or any agreement for 2.6. the disposition, of any freehold or leasehold property contained in this Deed is a valid disposition in accordance with section 2(1) of the Law of Property (Miscellaneous Provisions) Act 1989.
- If the Lender considers that an amount paid to it under a Finance Document is capable of being avoided or otherwise set aside on the liquidation or administration of the payer or otherwise, then that amount shall not be considered to have been irrevocably paid for the purposes of this Deed.
- Unless the context otherwise requires, a reference to a Security Asset includes the proceeds of any disposal of that Security Asset,

3. Third party rights

- Unless expressly provided to the contrary in a Finance Document, a person who is not a Party has no right under the Contracts (Rights of Third Parties) Act 1999 (the Third Parties Act) to enforce or to enjoy the benefit of any term of this Deed.
- Notwithstanding any term of any Finance Document, the consent of any person who is not a Party is not required to rescind or vary 3.2. this Deed at any time.
- Any Receiver or any delegate or sub-delegate of the Lender or any Receiver may enforce and enjoy the benefit of any Clause which expressly confers rights on it, subject to paragraph (b) above and the provisions of the Third Parties Act. 3.3.
