This form relates to: (i) 1,002 ordinary shares in the capital of GE Capital International 6 Limited (the "Company") that were purportedly cancelled as a result of a share buyback that purportedly took place on 5 December 2018 (the "Buyback"); and (ii) 12,000 ordinary shares in the Company that were purportedly cancelled as a result of a capital reduction that purportedly became effective on 4 March 2019 (the "Reduction"). Since 5 December 2018, it has been discovered that the levels of distributable reserves held by the Company were lower than had been thought and therefore the Buyback was void under the Companies Act 2006. This also invalidates the Reduction, since the special resolution approving this was drafted, circulated and passed on the basis that the Buyback had been effective. This form is intended to clarify that such ordinary shares were not cancelled and remain in issue.
