1. STATUTORY INFORMATION

Passageways (UK) Limited is a private company limited by shares and incorporated in England and Wales. The address of the company's registered office is 57 London Road, High Wycombe, Buckinghamshire, HP11 1BS. The registered number is 10261635.

The presentation currency of these financial statements is Sterling (£), being the currency of the primary economic market in which the entity operates (its functional currency). All amounts in these financial statements have been rounded to the nearest pound unless stated otherwise.

2. AVERAGE NUMBER OF EMPLOYEES

The average number of employees during the year was 8 (2018 - 3) .

3. OTHER FINANCIAL COMMITMENTS

Total financial commitments, guarantees and contingencies not included in the statement of financial position amount to £33,800 (2018 - £67,600), which relates to operating lease commitments.
