# PART 1 - GENERAL DESCRIPTION OF THE COMPANY'S ACTIVITIES AND IMPACT In the space provided below, please insert a general account of the company's activities in the financial year to which the report relates, including a description of how they have benefited the community.

The past year we have secured funding grants from various sources to deliver a variety of Projects for the benefit of the Glebe Farm Community; we had a grant from the SJM Fund to deliver a Project involving young people who witness or suffer from Domestic Violence Abuse; we secured a place of safety for the young children to go for a few hours to relax and get away from the environment they are currently in; to have some fun playing football, table tennis, board games, pool and netball etc and access to a volunteer Counsellor. We worked with various partners St Richards Church, DIVAS, Community Engagement Services C.I.C. The young children and their parents benefitted enormously, from the Project via getting away to a safe place to have fun and forget about their worries for a few hours; getting to know others from similar circumstances and making new friends.

We received funding from the Ageing Better in Birmingham Fund to run an 'Over 50's Luncheon Club' for 6 months where socially isolated and lonely older people from our Community attended. This has been a great success and has benefitted the elderly residents and the Community enormously; we discussed and acted upon any concerns or issues they had within their lives; we made everyone welcome and even took them out for a Christmas meal. We delivered the sessions so well that the Ageing Better in Birmingham Fund sent their Marketing and Publicity person out to take photo's, interview clients and write down comments from our clients about our group; then published them on their website with a big write up and photo's. This will also benefit the Community via putting their area on the Map and highlighting the excellent work of our volunteers.

We have been working in partnership with Saltley Community Association from Alum Rock and Community Engagement Services C.I.C. on a 'Building Bridges Project' via funding from the Church Urban Fund; Near Neighbours Grant to bring people from different cultures, faiths, ethnicities, backgrounds and genders together; to breakdown barriers between these Communities and to address Community Engagement & Cohesion issues within the Communities of Glebe Farm and Alum Rock. We did this via visiting each other's area, shopping centres, community facilities and places of worship. We took part in delivering various activities together; playing Badminton, going on bike rides and nature walks. We also had various meals together and discussion forums to inform and educate each other in regards to our differing cultures and values. This has benefitted these residents within these Communities enormously via breaking down peoples' barriers and perceptions of others who are newly arrived in the Country and living within their Communities. It has also benefitted these Communities via having a greater impact on better Community Engagement and Community Cohesion between these Communities and a better understanding of each others values and beliefs.

We have just received a Funding Grant from the Big Lottery Fund to deliver a 'Community Engagement Project' for the Glebe Farm Community which started in April 18 to deliver an outreach programme involving young and older people; deliver a 'Music Project' for young people; a Social Group for isolated and lonely older people; Community Event and Community Meetings for local people. We are working in partnership with Shilonite Gospel Church, Glebe Farm Football Club, RBNINC C.I.C., Saxon Way Studio's, FitCap C.I.C. and Community Engagement Services C.I.C. to deliver the various activities. We will update on the progress of this Project in our next report in May 2019.

Our stakeholders are Statutory Partners; Education, Police, Council Officers, Charities, Social Enterprises, Voluntary and Community groups; Community Engagement Services C.I.C., DIVAS, St Richards Church, Saltley Community Association, Shilonite Gospel Church, RBNINC C.I.C., Saxon Way Studio's, Glebe Farm Football Club, FitCap C.I.C. and most importantly, the Local Residents of Glebe Farm and surrounding areas in the Birmingham Communities we work within.

We always carry out in-depth consultations with the Communities we are proposing to work within before embarking on any of our Community Projects. This is to ensure that our Projects are relevant and meets the needs of the communities we work with. We do this via conducting outreach work and consultations with young and older people, local residents' groups, police, businesses and youth & community groups within these Communities.

As a result of conducting these consultations with our stakeholders and local residents mentioned above; our Company Directors listened to the feedback from the families suffering from Domestic Violence Abuse and local group DIVAS i.e. the need for a 'Place of Safety' was most important where activities they we like to take part in could be delivered; we did this via discussions with them and the local Vicar from St Richards Church. It was decided that this venue was safe and had the facilities for the activities they wanted to take part in; we then went ahead a sourced some funding from the SJM Fund. Working with families who suffer from Domestic Violence Abuse is very sensitive and there are specific ways in how to work with these families; we learnt some invaluable skills in our consultations with them and our partners and will be using those skills in future when engaging with those who suffer from Domestic Violence Abuse.

In regards to our Near Neighbours Project we consulted with Community Groups in Alum Rock, Stechford & Yardley North and Glebe Farm; the feedback we received from these groups and residents were invaluable in order for us to successfully deliver the Project. We listened to how to engage with residents in the different Communities we were proposing to work in; made contact and took on-board what kind of activities they would like to take part in; then ensured we had the resources and funding to deliver the activities. The response at the end of the project was very encouraging and the Communities we worked with would like us to try and sustain the work we have already completed via accessing more funding; which we are in the process of doing.

It is fair to say, that all of our projects involve a consultation process.
