#### **Receipts and Payments**

I enclose Receipts and Payments accounts for the Final Period for the Companies showing a balance of nil in hand in each case. The accounts show that there have been no amounts realised or paid out in the Final Period, and also detail the amounts shown on the Statement of Assets and Liabilities included in the Declaration of Solvency sworn by the Directors for the Companies.

The Joint Liquidators' expenses are discussed in further detail later in this report.

#### **Creditors**

There were no external creditors listed on the declarations of solvency and no claims have been received.

Howbury Park GP Limited ('GP') is the sole member of Howbury Park SPV Limited ('SPV'), and GP owes SPV £1 in respect of unpaid share capital. This debt was extinguished when SPV made a first and final distribution in specie of £1 to GP (see later).

#### HM Revenue & Customs ('HMRC')

As a matter of course we obtain clearances from the corporation tax team, and the Enforcement & Insolvency Service ('EIS') which deals with VAT and PAYE (as appropriate) and issues HMRC's claim for all taxes.

SEGRO (Howbury) Limited ('Howwbury') was part of a VAT group and we have received confirmation that the company has been removed from the group. With regard to corporation tax, SEGRO's tax manager advised HMRC that there were no movements in the final pre-liquidation period and the Large Business Office has agreed that no returns are required for this period.

We have recently received all clearances required and are now in a position to close the liquidations.

#### **Distributions**

A first and final distribution in specie of £1 was received by GP from SPV on 1 February 2022, thereby extinguishing the £1 owed by the Company to its subsidiary.

Further to this, a first and final distribution in specie of the £100 owed by group companies to GP was made to its members on 1 February 2022.

In addition, SEGRO made first and final distribution in specie of the £100 owed by group companies to its sole member on 1 February 2022.

#### Joint Liquidators' remuneration
