

BETWEEN:

NOW IT IS HEREBY AGREED as follows:

1. Definitions and Interpretation

In this Agreement:

"Commencement Date" The date of this Agreement

"Default" Means any event or circumstances as specified in Clause

5;"Final Repayment Date" A date to be agreed by both parties

"Interest Rate" 1% per month

"Loan" The loan facility made available under this Agreement in the

sum of £75,000

"Repayment Dates" From the first anniversary of the date of this Agreement and

12-monthly thereafter

2. The Facility

The Lender agrees to provide the Borrower with the Loan under the terms of this Agreement.

3. Commencement

This Agreement shall be deemed to be made on the day it is received by the Lender having been signed by the Borrower.

4. Purpose

- 4.1 The Borrower shall use all sums borrowed by it under this Agreement for the provision of regulated consumer credit lending, to include associated business costs and regulatory fees.
- 4.2 The Lender is not obliged to monitor or verify how any amount under this Agreement is used.

4.3 The Borrower is not permitted to advance any part of the Loan to Mark Winter for his personal benefit. All monies and profits due and paid by the Borrower under this Agreement are for the benefit of the MWC Pension Scheme.

5. Default

- 5.1 The Loan plus interest and charges on Default shall (subject to the service of notice and/or the obtaining of any court order) become immediately due (including interest) and payable by the Borrower, in so far as then remaining unpaid, if any of the following events occurs: -
 - 5.1.1 Non-payment of any payments due (including interest) within 14 days from the date on which it is due;
 - 5.1.2 Any information given or representation made by or at the request of the Borrower to the Lender in proving to be inaccurate;
 - 5.1.3 Commencement of any insolvency proceedings against the Borrower, or the Borrower making an arrangement with creditors
 - 5.1.4 Any procedure being used against the Borrower, or the Borrower making an arrangement with creditors
 - 5.1.5 Any procedure being used against the Borrower to attach or take possession of business assets for payment of a debt
 - 5.1.6 Use of the Loan otherwise than as specified in this agreement.
- 5.2 The Borrower shall be liable for any costs incurred by the Lender in taking any steps to obtain payment of monies due under this Agreement.

6. Set Off

The Lender may set off any amounts due under this Agreement against any sums owing to the Lender by the Borrower, or vice versa.

7. Security

The Borrower agrees to secure the repayment of the Loan by executing a charge on the company valid from the commencement date until the advance is fully redeemed.

8. Drawdowns

The Lender agrees to authorise the Borrower to draw down the Loan whether in full, or if requested by the Borrower, in tranches to, or for the account of, the Borrower.

9. Repayments

- 9.1 Subject to the terms of this Agreement the Borrower will repay the loan as follows:-
- 9.1.1 in the first year of the Agreement the Borrower shall roll interest up to become payable on the 12-month anniversary from the date of commencement
- 9.2.2 for the remainder of the term of this Agreement the Borrower shall make interest repayments every 12 months thereafter.
- 9.2 Without any obligation upon the Lender to do so, the Lender shall be entitled to allow the Borrower extended time to pay or grant any other indulgence to the Borrower without affecting any of the rights of the Lender in whole or in part.
- 9.3 The Loan will be granted on a rolling contract basis and will be redeemed on a Final Repayment Date to be agreed by the Lender and the Borrower.

10. Assignment

- 10.1 The Lender may assign any of its rights, or transfer any of its rights or obligations by novation.
- 10.2 The Borrower may not assign any of its rights or obligations under this Agreement.

11. Communications

- 11.1 All communications between the parties about the loan shall be in writing and delivered by hand or sent by pre-paid envelope first class post or sent by fax or email:
 - 11.1.1 (in the case of communications to the Lender) to its registered office or such changed address as shall be notified to the Borrower by the Lender; or
 - 11.1.2 (in the case of communication to the Borrower) to the registered office of the Borrower (if it is a company) or (in any other case) to any address of the Borrower set out in any document which forms part of the Contract or such other address as shall be notified to the Lender by the Borrower.
- 11.2 Communications shall be deemed to have been received:
 - 11.2.1 if sent by pre-paid first-class post, two Business Days after posting (exclusive of the day of posting); or
 - 11.2.2 if delivered by hand, on the day of delivery; or
 - 11.2.3 if sent by fax or email on a Business Day prior to 4pm, at the time of transmission and otherwise on the next Business Day.

12. Governing Law and Jurisdiction

The Agreement shall be governed by, construed and enforced in accordance with the law of England and Wales to the jurisdiction of which the parties hereto submit.
