#### Company activities and impact

The Power of Drums CIC is a drumming organization set up to serve and provide drumming facilities for the local community. This is our second full year as a CIC, after having a successful first year. We are now established as a community interest company and started this financial year with a 12-session contract with Stonebridge City Farm for pre-school-aged children. This was well received and by the community and staff at the Stonebridge City Farm. At around the same time, we had weekly sessions in a children's day nursery which continued for about three months. Throughout the Autumn and Spring, we held regular weekly sessions, alternating between the Trent Bridge Inn and the drumming in the caves of the Olde Salutation Inn. These sessions were very popular, attracting a varied range of people of all ages. We had regular members and people who came less frequently but the holding of regular sessions helped us build up a good reputation and become more known within the community. As part of the Nottingham City Council annual 'Light Night' in February 2020, we were invited to take part in it, and we provided drumming facilities in the caves over a weekend. These sessions were funded by the council and were free to the public. The daytime session which we held on Saturday was aimed at families and was well attended. In March 2020, Covid-19, began to take hold in the UK, which led to a national lockdown, and unfortunately, we had to cancel all our drumming sessions and bookings.
