#### Company activities and impact

Unleashing Refugee Potential (URP) is a refugee led company which supports refugees and migrant communities into employment, education and entrepreneurship. Employment Matching: We recruited 48 unemployed and economically inactive refugees and migrants and 20 of them have secured temporary and permanent jobs. Our support includes tailored individual support identifying potential skills, create CV, Searching for Job, filling application forms and one-to-one interview technique support and group session on peer support. We value the experience of our target groups and we keep our relationship by establishing peer support online discussions and experience sharing. We found this model increase confidence and inspiring many of our clients. Business Support: Entrepreneurship is another way to enable refugees work and leverage their skills from their home countries. We have supported 15 businesses and self-employed individuals. We also provided one-to-one advise, registration with companies house and how to keep records of income and expenses. Clients are also benefiting from the 1-2-1 digital skill support ranging from creating email account, excel sheets and zoom accounts and how to use for their work. Educational and Training Support: We provided online tuition to young refugees and asylum seekers by linking them with Volunteer Tutors to deliver 2 hours of online tuition per week. We Provided support to parents through assessing their needs and linking them up with relevant support services, including our in-house employment support. We have also created peer support groups for parents to discuss issues they face around UK systems, education and parenting. We recruited a team of committed Volunteer (35) Tutors through our partnerships with Leeds Trinity University and Enactus at University of Leeds. In total 210 hours of tuition were delivered until 09/05/2021 and £1050 of money has been saved- the minimum fee of £10 per week fortwo hours of tuition.

#### Consultation with stakeholders

Throughout the pandemic, many of the families we have been supporting expressed their pain they have felt to us around home learning, which led to us conducting research into home learning inequalities among refugees, asylum seekers and migrant communities.https://urp.org.uk/wp-content/uploads/2020/06/URP-Home-Learning-Inequalities.-2-1.pdfFollowing our research, we had a consultation with stakeholders which included Parents, Students, Teachers, City Council Education Departments, as a response we designed Thriving Families Project with a goal to minimise the educational inequalities that unfairly affect pupils from refugee, asylum seeker, and migrant backgrounds. Refugees and asylum seekers face extreme poverty in the UK, which has put them at a significant disadvantage. Most of our beneficiaries are living in the most deprived areas of Leeds, which put their schools under enormous pressure to meet the demand of their pupils throughthe pandemic. Parents are now extremely concerned that their children are falling behind and have lost confidence from not attending school. Many of our beneficiaries do not have suitable home learning environments or access to IT equipment and internet connection. In addition, the parents face additional cultural and language barriers, which prevent them from supporting their children's schoolwork, communicating with schools and understanding the curriculum.Refugee and asylum-seeking pupils are at a disadvantage compared to their peers who have suitable home learning environments and can afford to pay for tuition, causing them to fall behind their peers. We are deeply concerned that if they do not receive the extra support they need to catch up, their future opportunities and choices will be compromised. Through Thriving Families project we delivered 210 hours of tuition. Through word of mouth and our service delivery, we nowhave 30+ more families on our waiting list for tuition.
