The company delivers fully funded projects to vulnerable women across Lincolnshire, focusing on mental health, physical strength and mindfulness. This has included:

- Heroes' Project: a range of online health sessions for key workers from July 2020 to January 2021. £8659 from the National Lottery Coronavirus Community Support Fund.
- Postnatal Project: online specialist postnatal strength training sessions for women at risk of postnatal depression and anxiety, between October 2020 and April 2021. £3,910 from the Comic Relief Community Fund.
- Untold Art Project: a 12-week art-based mindfulness course for women disproportionately affected by the coronavirus pandemic, delivered between February 2021 and May 2021. £4,420 from the Lincolnshire County Council Covid-19 Community Response Fund, through the Lincolnshire Community Foundation.
- A number of other funding bids have been approved, to begin post April 2021, with funding to a total of £39,914 transferred into our accounts before the year end. These projects include mentoring the next generation of lived experience leadership in sports and physical activity (National Lottery Leaders with Lived Experience), cancer exercise sessions (Wave 10 Mental Health Promotion Fund) and an Impact Report (National Emergencies Trust, through the Lincolnshire Community Foundation).

We have also delivered subsidised postnatal sessions to women at risk of postnatal depression and anxiety. This totalled £1170 and 195 sessions, paid for through fundraising and the Lincoln Community Lottery.
