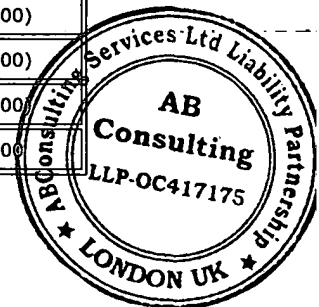
ABCONSULTING SERVICES LLP is subsequently exempt from having an audit for the above financial year.
