#### 1 Statutory information

Ross Motors (Edinburgh) Limited is a private company, limited by shares, registered in Scotland, registration number SC032254. The registered office is Braidbank House, 169 Braid Road, Edinburgh, EH10 6JE.

#### 2 Compliance with accounting standards

The accounts have been prepared in accordance with the provisions of FRS 102 Section 1A Small Entities. There were no material departures from that standard.

#### 3 Accounting policies

The principal accounting policies adopted in the preparation of the financial statements are set out below and have remained unchanged from the previous period, and also have been consistently applied within the same accounts.

#### Basis of preparation

#### Presentation currency

The accounts are presented in £ sterling.

#### Revenue Recognition

#### 6 Transactions with related parties

The company was under the control of Ms V Ross throughout the entire period and the previous period. Ms V Ross is the managing director and sole shareholder.
