Will be recruiting and hope to find successors who will take a keen interest in our work. We have recently welcomed Dorothy McDonald to the board of trustees. Dorothy is an existing home visiting volunteer and we very much appreciate the link Dorothy provides between the board and volunteers.

This year we have welcomed two new staff members on a pilot post to allow us to widen our reach and support families with a higher level of need with a family support worker.

I am very proud of this small organisation's contribution to the Perth and Kinross community, particularly in a time where many families with young children continue to be impacted by matters such as isolation and the ongoing cost of living crisis. I hope new volunteers and new funders will want to support its work in the coming year.

REPORT OF THE TRUSTEES FOR THE YEAR ENDED 31 MARCH 2023

Our Trustees are directors for company law purposes and trustees for charity law purposes and are pleased to present their report and financial statements for Home-Start Perth and Kinross for the year ending 31 March 2023.

Governing document

Home-Start Perth and Kinross is a company limited by guarantee and it incorporated on 2 June 2004. It was first registered as a charity (under the name Home-Start Perth) on 23 June 1984 and a change of name took effect from 1 November 2020 reflecting its operations across the whole of Perth & Kinross. Home-Start Perth and Kinross is affiliated to the Home-Start UK network and a signatory to the Home-Start Agreement. It engages in the Home-Start Scotland Forum. Home-Start Perth and Kinross is governed under Articles of Association adopted in December 2014 (under the name Home-Start Perth). Statutory regulators are the Office of the Scotlish Charity Regulator (OSCR) and Companies House. Any individual who wishes to support the objects may become a Friend of Home-Start Perth and Kinross. In the event of the company's being wound up, the Members, who are the serving trustees, would each be required to contribute up to £1.

Organisational structure, Trustee recruitment, Planning, Risk Management

The Board has met five times over the reporting period, to overview operations and context, develop and sign off a new three-year strategy, consider financial and staffing needs as well as future skills needs in relation to trustee recruitment. All Board meetings were held in person. Several trustees are specifically nominated to advise on Child Protection, HR, Finance and GDPR.

Trustees serving over the period have contributed to governance discussions from their experience and respective knowledge of the law, teaching, medicine (GP), charity and business administration, social prescribing, volunteering with Home-Start, previous experience of heading up a Home-Start service. Trustees were signposted to relevant training opportunities and to webinars on aspects of charitable governance; our Chair participates in the Home-Start UK Chairs' Forum. We were sorry to lose trustees Hannah Dalgety and Samaira Ali who resigned for personal reasons. This brought trustee numbers to four at March 2023, albeit with trustee recruitment already planned. Findings of a review of skills needs, led by Vice-Chair Tim Kearns and considered by the Board in March will inform recruitment for financial skills, ahead of current Treasurer Karen Paterson's retirement, IT and marketing experience as well as interest from individuals who can support our mission and work in the community in other ways.

As we moved on from concerns relating to Covid-19, main priorities have been around ensuring capacity in terms of our volunteer cohort and our staff team, to support numbers of referrals, and the associated level of service promotion to the typical professional services which refer people to Home-Start's services in Perth and Kinross.

Related parties

The principal related party is Home-Start UK, the umbrella organisation for Home-Start schemes in the UK, supporting them with establishment, procedure and policies in return for an annual fee which is a percentage of each scheme's latest reported annual income.

Objectives and activities

Home-Start Perth and Kinross's charitable purposes are:

- safeguarding the mental and physical health of children and parents of children
- helping to prevent maltreatment of children
- helping to relieve sickness and need amongst children and parents of children and
- promoting awareness around approaches and standards of childcare

Our services are designed to provide support in service users' homes and in familiar community settings across Perth and Kinross. These are tailored to help parents caring for young children, facing mental and physical health challenge, disability, bereavement, financial difficulty or deprivation, relationship difficulties, among other challenges. Parents or carers can be referred by professionals and can self-refer to our services at any time including antenatally and throughout the period until their youngest child reaches age 5. Current services are:

- Home Visiting Family Support
- Infant Massage (training for parents and carers)
- Breast Buddies (support antenatally, and with breastfeeding and infant nurture)

We operate a trusted and effective peer-support model, where regular support is provided by peer volunteers recruited locally, who have child-care or parenting experience. We provide volunteers with training and ongoing support via our Coordinators. Coordinators and volunteers are informed on a range of other specialist support services to which to signpost as needed, for example, mental and physical health needs, child development, bereavement, finance, disability, relationship breakdown. We work in partnership with other local third sector organisations and public health professionals, all of which can refer people to Home-Start Perth and Kinross.


Achievements and performance

In the second half of the reporting year, Home-Start Perth and Kinross carried out a review of strategy, involving trustees and staff in discussion of our performance over recent years and future direction. We took account of feedback about the services from peer volunteers, service users, local partner organisations and referrers, and have developed a fresh three-year strategy which will take effect from April 2023 and run to March 2026.



In this current cost of living crisis, parenting can be harder than ever before, and we are proud to stand alongside side our families and help them navigate such a tricky time.




Many of our supported families enjoyed a day trip to Auchingarrich Wildlife Park. It was lovely to watch the faces of the children as they came across new animals and new experiences.







Infant mossage group was a good opportunity for me to meet new people as I have just moved into the area. I have made a new friend in the group we have met up for coffee.

It was lovely to meet the other parents because I do not have Irlends with babies. I have made o new Irlend in the group so we will meet up after the group has linished.

The group has boosted my confidence after Covid it was great to meet new people. We have made a whots app group and we will meet up with each other on a regular boals. My body really enjoyed being massaged and she always sleeps well after a mossage.

FAMILY FEEDBACK

Having a peer supporter provided invaluable support in the first few months. There were times when it felt so challenging and I wasn't sure if I was giving my boby enough milk. The peer supporter helped alleviate my warries and kept me going. Attending the group also helped me to meet other mums and make friends.

Having breastleeding friends helps normalise it and gave me conlidence to keep going. The WhatsApp group provides lots of useful sources and information. I think the journey would have been far lonelier without BR.



The broastfeeding group in Kinross helped with charting to peer supporters and other mums to be able to talk about things and know that you're not alone in things and helped with confidence in breastfeeding and to continue with it. The WhatsApp group is always very helpful too, everyone is willing to offer advice.

FAMILY FEEDBACK



Breast Buddles was crucial to my well-being and breastfeeding journey. I was a first time mum, and BB was the first group I attended (and remained my favourite all through maternity leave!) it's where I made losting friendships and found the most support. It's an incredibly important resource, and I'm so grateful to have had it. Looking forward to attending again when we have our next one!

I think I probably would have just fully switched to formula if I hadn't been given advice on how to help increase my supply. Very grateful for the knowledge

Financial review and reserves policy

Trustees are satisfied that Home-Start Perth and Kinross through its operations continues to play an active part in supporting community needs, informing and empowering parents who face a range of challenges in family life. During 2022/2023 we were in a position to invest over £12,900 of free reserves in the two pilots mentioned above.

Some of our budgeted programme for coming years already has the committed support of a range of funders to early 2026, whilst financial support for other areas will reach cycle-ends during 2024 and 2025. We will focus our fundraising on those areas first, and as always try to ensure a degree of sustainability which gives us the important scope to plan for the future and to develop services in relation to changing needs and demand.

The presentation of the accounts at 31 March 2023 shows net assets of £230,330 of which £86,462 relates to Restricted Funds. The organisation held £143,868 in Unrestricted Funds, of which £78,792 has been transferred to the Designated Fund (see note below).

Free reserves at 31 March 2023 stood at £65,076, this reduction is chiefly the result of the investment in the pilot posts mentioned above and the associated increase in Designated Fund arising from this.

Home-Start Perth and Kinross policy is to hold in our Designated Fund at least 3 months' running costs together with costs of winding up the charity, should that be required. The required figure is reviewed annually, most recently in March 2023. Its level is detailed in the accompanying notes to the financial statements.

Plans for the year ahead

A priority, as we look to 2023/24, is to secure funding from both public sector streams and charitable trusts to sustain our popular Breast Buddies service for mums and infants across Perth and Kinross, and retain the skills and experience of Jocelyn Smith who coordinates this work. The impact of budget cuts nationally raises question marks about how such peer-support in the community should and can be funded in coming years, and this is a challenge to many small operations like ours. We appreciate the support of colleagues at NHS Tayside in exploring the public funding sector.

We look forward to putting our fresh three-year strategy into effect; this builds on the positive work of previous years, with some detailed adjustments to services, the continuation of the two pilots mentioned above and hopefully the start of a Nurture group in Perth. Within the strategy is the intention to harness support from a higher number of volunteers, for all our services, and to identify younger people who would like to support a younger generation of mums.

Also planned is recruitment from late spring 2023 for new Home-Start Trustees, with a view to expanding the range of skills on our Board as well as identifying a new Treasurer to succeed Karen Paterson.

We wish to ensure our networking with professionals in health and social care and with a number of local third sector community groups, to ensure strong mutual understanding of each other's services, to which we can all signpost families we will be supporting.

As ever, we will invest in building relationships with new funding organisations to sustain our work and our very committed staff team.

1 Accounting policies

Charity information

Home-Start Perth and Kinross Ltd is a private company limited by guarantee incorporated in Scotland. The registered office is The Gateway, North Methven Street, Perth, PH1 5PP.

1.1 Basis of preparation

The financial statements have been prepared in accordance with the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 (as amended) and "Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)". The Charity is a Public Benefit Entity as defined by FRS 102.

The financial statements are prepared in sterling, which is the functional currency of the Charity. Monetary amounts in these financial statements are rounded to the nearest £.

1.2 Company status

The charity is a private company limited by guarantee and does not have a share capital. The extent of the liability of the members of the company, in accordance with the memorandum of association, is limited to a maximum of £1 per member. The company is also a registered charity and accordingly no liability to corporation tax arises on its income.

1.3 Going concern

At the time of approving the accounts, the trustees have a reasonable expectation that the charity has adequate resources to continue in operational existence for the foreseeable future. Thus the directors continue to adopt the going concern basis of accounting in preparing these financial statements.

1.4 Fund accounting

General funds are unrestricted funds which are available for use at the discretion of the trustees in furtherance of the general objectives of the charity and which have not been designated for other purposes.

Designated funds comprise of unrestricted funds that have been set aside by the trustees for particular purposes. The aim and use of each designated fund is set out in the notes to the financial statements.

Restricted funds are subjected to restrictions on their expenditure imposed by the provider of the funds.

1.5 Income recognition

All incoming resources are recognised once the charity has entitlement to the resources, it is probable the resources will be received and the monetary value of incoming resources can be measured with sufficient reliability. For legacies, entitlement is the earlier of the charity being notified of an impending distribution or the legacy being received.

Gifts donated for resale are included as income when they are sold. Donated facilities are included at the value to the charity where this can be quantified and a third party is bearing the cost. No amounts are included in the financial statements for services donated by volunteers.

Investment income is included when receivable.

1.6 Expenditure recognition

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that settlement will be required and the amount of the obligation can be measured reliably. All expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all costs relating to the category. Support costs are those costs incurred directly in support of expenditure on the objects of the charity. Management and administration costs are those incurred in connection with administration of the charity and compliance with constitutional and statutory requirements. VAT, which cannot be recovered, is reported as part of the expenditure to which it relates.

1.7 Tangible fixed assets and depreciation

Tangible fixed assets are stated at cost less accumulated depreciation. The cost of minor additions or those costing below £500 are not capitalised. Depreciation is charged to write off the cost less estimated residual value as follows:

Computer equipment

15% per annum reducing balance

1.8 Cash and cash equivalents

Cash and cash equivalents include cash in hand, deposits held at call with banks and other short-term liquid investments with original maturities of three months or less.

1.9 Creditors and provisions

Creditors and provisions are recognised where the charity has a present obligation resulting from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors and provisions are normally recognised at their settlement amount after allowing for any trade discounts due.

1.10 Pension costs

The charity does not operate its own pension scheme however does contribute to individual employees' personal plans. Contributions payable are charged to the Statement of Financial Activities in the year they are payable.

The board considers it prudent to ring-fence an amount out of unrestricted funds to cover business contingency costs in the event of the charity ceasing to be a going concern. The Board prefer to view unrestricted funds after taking account of these costs to ensure they can always be covered.

Purpose of restricted funds

Gannochy Trust

This grant will be used to support our services for families across Perth and Kinross, in particular Family Support and Infant Massage Services.

NHS - MIN Fund

This funding has been received in order to improve the support and training available to the Perth and Kinross breastfeeding group through the appointment of a peer support co-ordinator.

PKC - CIF Fund

This funding has been received in order to fund training for Breast Buddies volunteers to enhance improve support currently provided/offered by the service.

Forteviot Charitable Trust

This grant was awarded to sustain and develop specific aspects of services that Home-Start Perth and Kinross provide and enable the organisation to respond to increased demand in the Perth and Scone area.

Tay FM - Cash for Kids

This funding received to enable Home-Start to help to feed families through holidays.

Robertson Trust

This grant was secured to sustain the Home-Start service in rural Perth & Kinross, also help to integrate family support, infant massage and Breast Buddies services in rural areas. At the year end we received a new grant of £30,000; this relates to the 2023/24 financial year and is to contribute towards our running costs.

NHS - MIN Small Grants

This funding was received in order to buy resources for Breast Buddies groups in various areas.

The National Lottery Community Fund

This grant was awarded to sustain and develop services that Home-Start Perth provide and enable the organisation to respond to increased demand.

HSUK - Emergency Grants

Received in order to aid us with costs incurred relating to technology. A sum of funding was also received to enable us to buy vouchers/provide funds for our families who are struggling financially.

HSUK - Caring for Families

Grant received in order to aid us with costs relating to technology and also to enable us to buy vouchers/provide fund for our families who are stuggling financially.

Cattanach Trust

This funding has been awarded to help us put the Breast Buddies project on a firmer footing.

PKAVS - Community Wellbeing and Mental Health Fund

To expand our reach within our family support/home visiting service, specifically targeting younger mums under the age of 25 and those families living in higher areas of poverty (SIMD 1 and 2).

14 Movement in funds (continued)

PKC - Food Insecurity During Holiday Periods Fund

This funding was received in order to alleviate food poverty in our supported families. This was achieved through the provision of shopping vouchers during holiday periods; a proportion was also used for the provision of a family day out including a picnic lunch.

PKC - Food, Bedding and Home Grant

This funding was received to enable us to provide food vouchers or warm winter bedding to vulnerable families.

STV Children's Appeal

This grant was received to enable us to provide support directly to our families who are experiencing real hardship, with food, heating and basic essentials.

Northwood Charitable Trust

Funding has been awarded in order to help sustain our key services of home visiting and Breast Buddies – it is to be spent during the 2023/24 financial year.

PKAVS - Community Wellbeing and Mental Health Fund - Nurture Group

Grant awarded to fund a group in Perth providing an instructor led exercise programme, suitable for all participants of differing fitness levels. Our coordinators will offer other activities such as storytelling; budgeting tips; crafting. This group will commence during the 2023/24 financial year.

15 Transfers between the funds

Due to the nature of the designated fund this balance is variable depending on the position of the charity. This resulted in a transfer of £11,312 (2022: £3,447) from general funds to the designated fund.
