The main work this year has been:

- Recruited more board members
- Secured a rental site for the business in Perthshire and negotiated the terms of lease and future purchase price
- Started renovating the site for use
- Made links within the Steiner Waldorf society
- Continued on the business manual

This will benefit the community as there is a deficit of residential child care provision in Perthshire and there is very little therapeutic support for looked after children to address the childhood trauma.

Due to Covid we have been unable to have a community consultation where the site is but we plan to do this as soon as is possible.

I have also connected with the Perth and Kinross Looked After children's support group and had 2 remote consultations with them to get feedback about the plans.
