PART 1 - GENERAL DESCRIPTION OF THE COMPANY'S ACTIVITIES AND IMPACT

Repairel CIC is a Glasgow-based startup social enterprise created to respond to the climate emergency and tackle fast-fashion by reducing the carbon footprint and human suffering caused by the footwear industry, while also helping the UK to recover from the economic impacts of Covid-19 and to deliver its Clean Growth Strategy and net zero targets.

Repairel CIC was registered as a CIC in July 2019. In the period from July 2019 - July 2020 the company conducted primary and secondary market and customer research, engaged with the community, future customers, potential partners and wider stakeholders, organised and run co-designing events, visited 3 community-led repair organisations for a community learning exchange, applied for funding (3 grants received in this time period), completed several social enterprise incubation programmes and built Repairel CIC's core team. A strong and diverse Board of Directors with complementary skill-sets and shared values was recruited. Their skills range from product design engineering, sustainability and circular economy, fashion and textile industry marketing to Glasgow commercial networking. From June 2020 Repairel CIC has been able to employ its first 2 paid employees - a part-time Development Officer (0.4FTE) and Managing Director (0.4FTE + 0.6FTE volunteered hours).

During the financial year 2019-2020, Repairel CIC's activities have benefited the community in the following ways:

- Raised the community member's awareness of the climate impacts of the footwear and wider fashion industry.
- Co-designed with the community potential solutions for mitigating these impacts.
- Increased the community member's knowledge of how to care for their footwear and the environment.

The company's stakeholders in 2019-2020 have predominantly been residents of Glasgow and surrounding area, in particular residents of the North West of Glasgow - Woodlands area (G3 7, G3 6, G4 9), Woodside (G3 7, G20 6, G4 9) and Garnethill (G4 9, G3 6, G2 3). This is a young, creative and dynamic community, home to 2 universities and almost a thousand student households at the last census. It is culturally and ethnically diverse: a quarter of its residents were born outside the UK and almost half don't identify as white British. It has a lot of inequality, with some areas among the 10% most deprived in Scotland. Many people live here for the duration of their studies and buy, accumulate and upon leaving discard a lot of apparel, including shoes. People who have limited financial resources, including students but also families on a budget, are trapped in a vicious cycle of buying cheap low quality shoes that don't last as long, discard them and buy new footwear more frequently. This contributes to the carbon footprint of the area.

To include the stakeholders in the solution design and ensure our offering matches people's needs and creates value for them, Repairel CIC conducted an extensive online survey, delivered a test-workshop and facilitated a community consultation using co-design methods:

#Online survey involving stakeholders in shaping our offering (193 received entries with data on how much people would pay for our products/services, which solutions they prefer, behaviour trends around footwear).

#Test-workshop "How To Care For Your Shoes & The Environment" (we gauged how concerned and informed people are about the environmental and social impacts relating to shoe-waste)

#Co-designing workshop/community consultation (many solutions proposed by participants coincided with our solutions and we got valuable feedback on how to shape our ideas to match what people want and what solutions are more viable to roll out first)


