The sheriff, having resumed consideration of the foregoing petition together with the productions produced, and having seen the digital publication of the Edinburgh Gazette dated 15 and 16 August 2022 and the E paper Press and Journal newspaper dated 13 August 2022 each containing the intimation ordered by the preceding interlocutor, no answers to said petition having been lodged in court, Finds (1) that the amount of the share capital of Bathroom Planet Limited, a Company incorporated under the Company Acts, Company Number SC658377 and having its registered office address at Pitmachie, Old Rayne, Inch, Aberdeenshire AB52 6RX paid up or credited as paid up does not exceed £120,000; and (2) that the said company is unable to pay its debts;

therefore Orders that the said company, be wound up in pursuance of the Insolvency Act, 1986; Nominates and Appoints Geoffrey Isaac Jacobs and Blair Carnegie Nimmo, Insolvency Practitioners, Interpath Limited, 130 St Vincent Street, Glasgow G2 5HF to be joint interim liquidators of the said company with the usual powers, all in terms of said Statute and of Law; Declares any act required or authorised under any enactment by the said joint interim liquidators as the case may be, is to be done by all or any one of the persons for the time being holding the office in question;

Finds the petitioner entitled to the expenses of this application and Directs same to be expenses in the liquidation.
